While most countries already use the 10th revision of these codes (or ICD-10), the United States has yet to adopt this convention. The Centers for Medicare & Medicaid Services (CMS) is working closely with all industry stakeholders to provide support in transitioning to ICD-10 on Oct. 1, 2015.

While the former version of the ICD had a mostly numeric structure, the ICD-10-CM utilizes an alphanumeric coding structure. For example, previously the code for Post-Traumatic Stress Disorder was simply 309.81. The new coding could be either F43.10, F43.11 or F43.12. Each component of the code refers to specific diagnostic information.
